### 1. Overview

This Change is required to improve the quality and accuracy of the Build Pack documentation for the WA Electricity Market.

### 1.1. Current State

The WA electricity market uses Build Pack (revision 2.0) as the basis for establishing electronic communication between the network operator and code participants under the Customer Transfer Code Communication Rules and Electricity Industry Metering Code Communication Rules.

The Build Pack defines the processes, procedures and methods used to communicate between the network operator and code participants.

The Build Pack has been developed by consultative process between code participants and is published at:

### 1.2. Reason for Change

While using the Build Pack, code participants have found the documentation to be lacking in detail and clarity, and to contain errors.

### 1.3. Proposed Change

Revise Electricity Market Build Pack documentation to revision 2.1.

- 1. As a result of this documentation revision, the document structure is more closely aligned with the NEM Build Pack document structure.
- 2. All corrected and upgraded documents are provided for code participant review with changes marked up.
- The B2B Procedures documents and B2B Processes Participant Build Pack are new documents based on the corresponding NEMMCO B2B documents and used under licence from NEMMCO. These are provided for code participant review with WA differences marked up.
- 4. No change has been made to the B2B interface itself. This change request is documentation only.
